## REMEMBER - HIERARCHY OF RISK CONTROL: Eliminate, Reduce, Isolate, Control, use Personal Protective Equipment, if required

- (1) Initial Risk Level is the assessed level of risk based on the control measures already in place.
- (2) Revised Risk Level is the assessed level of risk based on the preventative and protective control measures put in place to reduce the risk further.
